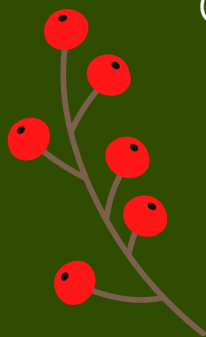

Letter from the President

Dear GSA Members,

As our organization approaches its fiftieth anniversary in 2026, the Executive Board has been drafting wording for mission and vision statements that will speak to our past, present, and future. In some ways, it is surprising that we do not yet have this verbiage in place after almost five decades; but in other ways it makes sense that we have worked well together without having to put our purpose and intentions into words so formally. We are a scholarly association in the singular, but made up of 1700 individuals who assemble and collaborate in multiple disciplinary configurations, scholarly interest groups, institutional communities, and social collectives. We share a commitment to studying the complex and diverse expressive texts, histories, and human experiences of German-speaking societies and the nations and cultures with which they intersect and interact; yet our methodologies, archives, theoretical vocabularies, and intentions differ in meaningful ways. As an organization we are guided by one set of bylaws, are represented by a single elected body in the form of the Executive Board, and practice long-standing traditions in the form of conference configurations, prize celebrations, and social customs, while also being invested in ongoing structural transformation that leads toward more equity and justice. As my presidency concludes, I want to thank all of our officers and multifaceted standing and ad hoc committees, networks, working groups and task forces for getting so much done, bringing new ideas into action, and drawing attention to areas where we need to improve and grow.

It is your diverse and intersecting knowledge sets, skills, and passions that have made a defining statement a moving target – in the most positive sense.

One of my goals as president has been to survey where documentation, process, governance, and management have been working well and to identify opportunities to further professionalize, formalize and more transparently communicate the approaches and operations of the Executive Council, Executive Board, and staff. (What is, for example, the difference between a committee, a working group, and a task force, and why does it matter?!) My experiences as an EB member, Vice President and over the past two years as President have taught me one thing for sure: there is no business as usual for the GSA. Within the past six years we have surmounted a global pandemic, a hybrid conference, the association's first convening outside the US, and a meeting already underway when a major tropical storm hit. Acts of violence and political threats that intersect with our work and impact people we care about deeply locally and globally have demanded our attention and scholarly responses. Such challenges have tested our resolve and resilience. I am convinced that, although we may enter our second half-century with as many questions as answers, we do so on steady footing.

Two of the people who have helped shape and steady our path through are moving on from their positions in January, Operations Director Jennifer Jenkins and Treasurer Tom Haakenson. It is no exaggeration to say that I cannot imagine where the GSA would be without their dedicated and expert labor, sound judgment, and close attention to the kinds of

details that the rest of us get to take for granted.

Tom and Jen, I am grateful for how committed you both have been to facilitating smooth transitions via the maintenance of institutional knowledge, values, continuities that are important to us as a community of scholars, teachers, and students. It is a good thing for the whole GSA that we get to keep you close as fellow members well beyond the new year.

It is certainly a bittersweet time as we face so much change at once. I am happy to report that Margaret Menninger and David Imhoof will continue to carry us through in their current overlapping terms as Executive Director and Secretary respectively, with David Meola succeeding Tom as Treasurer. A search for our new Operations Director is currently underway, and President-Elect Damani Partridge and incoming Vice President Todd Herzog are stepping into their new positions with a strong sense of purpose and motivation. I will remain reliant on all of you as I embark on my work on Arts Night and other projects in my two years as Immediate Past President. January will be an exciting month!

Thank you to the entire GSA membership for everything you have contributed recently. Please begin to gather your anecdotes, photographs, and documents of the past, and novel ideas for the future. We have fifty years to celebrate and, I hope, fifty more to plan.

CANDIDATES FOR GSA BOARD GERMANISTIK

Christine Rinne (University of South Alabama)

Christine Rinne (Ph.D., Indiana University, 2005) held two visiting positions before joining the faculty at the University of South Alabama. She is currently associate professor of German in the Department of Modern and Classical Languages and Literature, directs the International Studies program, and coordinates the Global Engagement Certificate. Her research focuses on reproductive labor and material culture through the lens of the maidservant in 19th- and 20th-century texts; she is currently exploring the cleaning lady's growing popularity in crime fiction. She is drafting a monograph entitled, *Soldiers Writing in Uncertainty: German POWs Prepare to Return Home*, which analyzes the content and format of newspapers published by German prisoners of war held at two camps in Alabama from 1943–46. She has presented her research at numerous GSA conferences, served on the 2016 and 2017 GSA program committees, and is a member of the GSA mentoring initiatives task force. She would welcome the opportunity to actively engage in GSA's conversation about how to best adapt to our evolving academic environment and develop new programming to better include scholars in all phases of their career.

Brett Sterling (University of Arkansas)

I am an Associate Professor of German at the University of Arkansas, Fayetteville. My research interests include German-language comics, diversity and representation in German-speaking Europe, and the works of Hermann Broch. My first book, *Hermann Broch and Mass Hysteria: Theory and Representation in the Age of Extremes*, analyzed how Broch used literature and theory as distinct but complementary means of conceiving and countering the mass hysteria of National Socialism. The book received the Radomír Luža prize in 2023. My current book project will present the first comprehensive history of German-language comics written in English. Since joining the GSA in 2014, I have worked consistently to promote the study of comics within German Studies by developing numerous panel series, as well as co-founding and co-organizing the GSA Comics Studies Network in 2017. As co-organizer, I have collaborated with colleagues in networks including Black Diaspora Studies, Queer and Trans Studies, and Asian German Studies. If elected, I would bring this interdisciplinary spirit to the GSA Board. I am especially eager to work for greater inclusivity and accessibility within the GSA. Further, I hope to work with colleagues to develop strategies for sustaining German Studies for the long term.

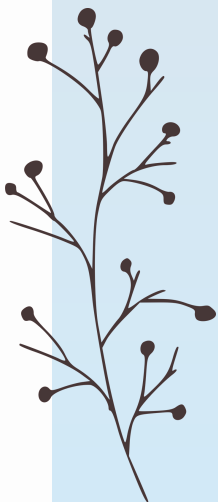

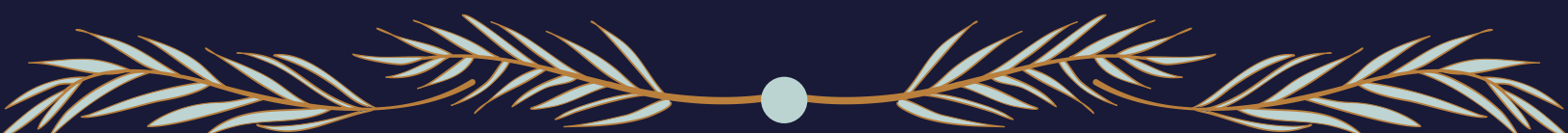

2024 ARCHIVES REPORT

1.) Bundesarchiv

1.1 Stasi-Unterlagen-Archiv

Seit Sommer 2021 gehört das Stasi-Unterlagen-Archiv mit 23 Standorten und rund 2300 Beschäftigten zum Bundesarchiv. Mit diesem Schritt wurden die Stasi-Unterlagen zu Archivgut des Bundes und damit als kulturelles Erbe Deutschlands dauerhaft gesichert. Seit Inkrafttreten des Stasi-Unterlagen-Gesetzes Ende 1991 registriert das Stasi-Unterlagen-Archiv ein reges Interesse an der Akteneinsicht: Insgesamt wurden bisher etwa 7,5 Millionen Anträge und Ersuchen zu Stasi-Unterlagen gestellt, davon rund 3,4 Millionen Anträge zur persönlichen Akteneinsicht. Im Jahr 2021 gab es 30.603 Bürgeranträge, 29.064 im Jahr 2022 und 16.385 Anträge bis Ende Juni 2023.

Während zunächst nur – weiterhin zahlreich nachfragende – Antragstellende aus den Bereichen Forschung und Medien ihre Unterlagen digital erhalten konnten, wurde das Verfahren seit dem Jahr 2021 auch für die persönliche Akteneinsicht eingeführt. Ebenso besteht die Möglichkeit zur Antragstellung an allen Standorten des Bundesarchivs. Der Bildungsbereich des Stasi-Unterlagen-Archivs ist ein etablierter Partner von Bildungs- und Aufarbeitungseinrichtungen – mit analogen und digitalen Angeboten, die weiter ausgebaut wurden. Insbesondere im vergangenen Jahr sind auch die Followerzahlen auf allen Social Media-Kanälen des Stasi-Unterlagen-Archivs stark angestiegen.

Seit Beginn der Transformation sind die Informationstechnik und alle Kapazitäten zur Digitalisierung von Unterlagen, zur Bestandserhaltung und zur Restaurierung von Archivgut zusammengeführt worden. Schon bisher verwahrte das Bundesarchiv die Überlieferungen der zentralen Stellen der DDR.
